Accommodation

If you intend to study in Hamburg, we therefore recommend that you apply as early as possible before starting your studies. You should also keep in mind that you will be asked regularly (every 2 weeks) via e-mail, whether you are still interested in one of our rooms. If yes, please confirm, otherwise you will no longer be on the list of applicants.

Finance

Study start-up aid

First year students under the age of 25, who are in receipt of social benefits (e.g. Bürgergeld, Wohngeld, Grundsicherung) during the month before the start of their studies, can apply for a so-called „Studienstarthilfe“ of € 1.000. BAföG

Under certain conditions, students with EU, EEA (European Economic Area; including Iceland, Liechtenstein, Norway) or Swiss citizenship can also receive BAföG. The requirements for the support in these cases are listed in §8 and §61 BAföG, see [Information Sheet BAföG in English](#) at www.stwhh.de/en/ ~ [International affairs](#) ~ [Students from abroad](#).

State funding for international students

If you are **not entitled to BAföG**, you may be eligible for benefits from state funding: The **merit scholarship** is awarded by the universities. Please contact your International Office. Students with EU, EEA or Swiss citizenship, who are not entitled to BAföG can receive an **examination scholarship** for their graduation (usually in the last 12 months of their studies) from state funding. Scholarships

There is no central office, where you can apply for a scholarship or which forwards an application to the funding institutions. You must actively search for scholarship providers yourself and apply individually. The German Academic Exchange Service DAAD awards scholarships for international students who wish to study in Germany. We recommend that you inform yourself in good time, i.e. approx. 1.5 years before the start of your studies, via the scholarship database at www.daad.de/en

Student loans

Students with EU, EEA or Swiss citizenship can take out a state student loan in exceptional cases. In the final phase of your studies, please check whether you are eligible for an interest-free loan. Good to know

Working

Roughly 75 % of the students in Hamburg work alongside their studies. For international students, the share is even higher. This makes working one of the most common forms of financing for students from abroad. Students with EU, EEA or Swiss citizenship have unrestricted access to the labour market. Since different aspects have to be considered when working alongside your studies and especially when combining multiple jobs or taking up self-employment, **it is therefore advisable to seek advice from our Counselling Centre for Social & International Affairs – BeSI before starting to work.**

Social benefits

Under certain conditions, students with EU, EEA or Swiss citizenship may be eligible for social benefits (e.g. housing benefit, child allowance, integration assistance), especially in the event of a change of study status (part-time, semester off) or in special circumstances, e. g. pregnancy/childcare, sickness/disability, etc.

Help in financial emergencies

Students of the University of Hamburg, Hamburg University of Applied Sciences, Hamburg University of Technology, Hamburg HafenCity University, Hamburg University of Fine Arts, Hamburg University of Music and Drama, Bucerius Law School and Berufliche Hochschule Hamburg, who find themselves in an unforeseen, acute, and temporary financial emergency loan, an aid or food vouchers for the cafeteria (Mensa) respectively from the emergency fund of Studierendenwerk Hamburg.

Health insurance

As a rule, students with EU, EEA or Swiss citizenship can remain insured in their home country and apply for a European Health Insurance Card (EHIC). This enables them to make limited use of medical services in Germany. However, when taking up a student job, a German health insurance may still be required.
